**INFORMATION CLAUSE
FOR MEMBERS OF
ORGANISATIONS AND ASSOCIATIONS OPERATING AT THE WROCLAW MEDICAL UNIVERSITY**

Pursuant to article 13 of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – GDPR) , we inform that:

1. The Controller of your data is Wroclaw Medical University with its registered office at Wybrzeże Pa steura 1, 50-367 Wrocław, hereinafter referred to as the "Controller", represented by the Rector.
2. The Controller has appointed a Data Protection Officer whom you can contact at the following email address: iod@umed.wroc.pl in relation to all issues associated with the processing of personal data.
3. Your personal data will be processed for the following purposes:
 - a) supporting the activities of student organisations and associations operating at the Wroclaw Medical University,
 - b) implementation of information, archiving, statistical and reporting obligations of the Controller, as provided by the provisions of generally applicable law and internal acts of the Controller,
 - c) marketing of services provided by the Controller – if applicable,
 - d) ensuring the safety of persons and property through the use of video surveillance system;
4. The legal basis for the processing of your personal data is:
 - a) Art. 6 sec. 1 point (a) of the GDPR, i.e. Your consent
 - b) Art. 6 sec. 1 point (c) of the GDPR, i.e. the provisions of the Law on Higher Education and other provisions applicable to the Controller.
5. Personal data shall only be processed insofar as such processing is necessary to achieve the objectives referred to in item 3, including those resulting from the documents and letters submitted by you.
6. The Controller may entrust the processing of your personal data on behalf of the Controller to another entity by a written agreement.
7. The Controller does not make your personal data available to any recipients, except for cases where such obligation results from generally applicable laws.
8. The Controller will store your personal data until the student organisations and associations cease their activity, and then for the period required by the provisions regarding reporting, archiving, financial statements and tax regulations.
9. You are entitled to withdraw your consent to the processing of personal data at any time. The withdrawal of the consent shall be without prejudice to the lawfulness of processing of your personal data prior to such withdrawal.
10. You have the right to access your personal data, correct and delete such data and limit its processing as well as object to the processing.
11. You have the right to file a complaint to a supervisory authority – the President of the Personal Data Protection Office – in case of suspicion that the processing of personal data by the Controller is conducted in violation of law.
12. Providing your personal data is voluntary, however, failure to provide it will make it impossible to support the activities of the student organisations and associations that you belong to.
13. The Controller does not use automated decision-making including the "profiling" of data referred to in Art. 4 point 4) of the GDPR, which is a form of automated processing of personal data consisting in using personal data to evaluate certain personal aspects of an individual.
